

MINUTES <u>COMMITTEE #1</u> REVENUES, DISBURSEMENTS, WATER AND WASTEWATER November 6, 2018

Committee #1 - Revenues, Disbursements, Water and Wastewater met on Tuesday, November 6, 2018 at 9:00 AM in the Council Chambers, City Hall, 30 West Central Street, Chippewa Falls, WI.

Committee Members present: Rob Kiefer, John Monarski, and Paul Nadreau Mayor/Other Council Members present: Mayor Hoffman Others present: Finance Manager/Treasurer Lynne Bauer, Director of Public Works/City Engineer/Utilities Manager Rick Rubenzer, Police Chief Matthew Kelm, Fire Chief Mike Hepfler, Library Director Joe Niese, Parks and Recreation Director Dick Hebert, Utility Office Manager Connie Freagon, Street & Maintenance Manager Rick Ruf.

Call to Order: 9:00 am

1. Discuss funding for Ashley Lane and bike trail extension associated with the Erickson Park project including a progress report and update letter to the DNR. Possible recommendations to the Council.

Dick Hebert summarized city involvement related to the reconstruction of the intersection of Ashley Lane and Jefferson Avenue and the extension of the bike trail. Hebert presented a progress report letter to the DNR detailing the City's funding commitment with an estimated timeline. This letter is needed to receive grant funding.

Motion by Kiefer/Nadreau to recommend the Council accept the DNR progress letter. All present voted aye. Motion carried.

2. Discuss possible purchases of Fire Department equipment from the proceeds of the WI Dept. of Veterans Affairs Grant. Possible recommendations to the Council.

Chief Hepfler presented his recommendation for use of the VA grant funds. He would like to purchase the following items:

MTS Powerload System with installation costs;

Power-Pro XT Cot:

Life Pak Cardiac Monitor.

He will also use \$6,000 in donation funding and \$991.00 of FAP/Act 102 monies. The total for all purchases is \$73,230.

Motion by Monarski/Nadreau to recommend the Council approve the fire equipment purchases from grant funds, donation funds and Act 102 funds. **All present voted aye. Motion carried.**

3. Discuss funding for Street Dept. equipment including monies from the "Sale of Scrap" account. Possible recommendations to the Council.

Street & Utility Maintenance Manager Rick Ruf presented a request to use sale of scrap funds to purchase a T2 asphalt Recycler. He explained the benefits of hot mix vs. cold mix and indicated there would be savings of approximately \$30/ton.

Finance Manager Lynne Bauer will review the scrap account balance with Mr. Ruf to determine if the funds are available for this purchase.

Motion by Monarski/Nadreau to recommend the Council authorize the purchase of the T2 asphalt recycler pending verification that the funds are available in the "Sale of Scrap" account. **All present voted aye. Motion carried.**

4. Review preliminary budget data and issues affecting the budget. Possible recommendations to the Council.

The following departments presented their proposed budgets including any omitted budget items:

Parks & Recreation Department; Finance Manager Bauer reviewed the following administration budgets: City Council; Mayor; Central Duplicating; Assessment of Property; Annexation of Property; Independent Auditing; City Attorney; Special Legal Counsel; Zoning Publication Notices; Tax Refunds and Chargebacks; Property/Liability Insurance; Cable (Franchise-2%) Fees.

No action taken.

Dear Ms. Norquist,

This letter is to provide a progress report and update on the Erickson Park Development in the City of Chippewa Falls.

Construction of Erickson Park began on May 14, 2018 and will be substantially completed by June 1, 2019. The project is on schedule and on budget.

As part of the project the City is pursuing constructing a new intersection at Ashley Lane and Jefferson Avenue. This will provide safer and easier access to Erickson Park. The City is also pursuing constructing a new bicycle trail connecting the Duncan Creek Bike Trail to Erickson Park on Jefferson Avenue. It is anticipated the new intersection will be contracted at an estimated cost of \$41,000 and completed by June 1, 2019. The new bike trail construction estimate is \$42,000 and will be completed by City Staff on or before fall of 2019.

Both the new intersection and bike trail will be funded by the City with assistance from private donations. Committee No. 1, Revenues, Disbursements, Water and Wastewater has recommended allocating \$50,000 toward the estimated \$83,000 cost of construction for the new intersection and bike trail with the remainder from private donations.

We will not be asking for Grant monies to fund these two parts, new intersection & bike trial extension, for the Erickson Park Development.
