CITY OF CHIPPEWA FALLS BOARD OF PUBLIC WORKS MEETING MINUTES MONDAY, JANUARY 25, 2021 - 5:30 PM

The Board of Public Works met in City Hall on Monday, January 25, 2021 at 5:30 PM. The meeting was live streamed from the council room in City Hall. Attending remotely were Mayor Greg Hoffman, Director of Public Works Rick Rubenzer P.E., Finance Manager Lynne Bauer and Alderperson Paul Olson. Darrin Senn was absent. Also attending remotely were Assistant City Engineer Bill McElroy P.E., City Planner Brad Hentschel, Alderperson Jason Hiess and Scott and Wendy Sullivan.

- 1. <u>Motion</u> by Olson, seconded by Bauer to approve the minutes of the December 21, 2020 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED.</u>
- 2. Scott and Wendy Sullivan appeared to support their request to discontinue and vacate the city alley section located along the east property line of 521 North Bridge Street. This is the former Salvation Army Building location. Director of Public Works Rubenzer gave a brief history that in 1989 when the Mega Holiday (SuperAmerica) requested the City to discontinue the western approximately 145 feet of the alley between Birch Street, Willow Street, Rushman Drive and Bridge Street, they were required to obtain the real estate that is now the section of alley being requested for vacation. Director of Public Works Rubenzer stated that normally a discontinuance/vacation petition includes representation signatures of as much alley frontage owner as possible. In this case, Mega Holiday may not be in favor of discontinuance. Mr. Sullivan went through the attached request with the Board stating "safety" as the main reason for discontinuance noting fork lifts would frequently be unloading deliveries. Director of Public Works Rubenzer noted that other city businesses used downtown alleys for delivery and suggested this be tried first before discontinuance. Snow removal and creating a "dead end" alley were also discussed as concerns. Motion by Olson, seconded by Rubenzer to recommend the Common Council refer the request of Scott and Wendy Sullivan to discontinue and vacate the city alley section located along the east property line of 521 North Bridge Street to Committee No. 3 for discussion and action. All present voting ave. MOTION CARRIED.
- 3. The Board of Public Works considered the attached Preliminary Resolution Declaring Intent to Levy Special Assessments. Assistant City Engineer McElroy described the proposed 2021 projects listed and the corresponding assessable items for each project.

 Motion by Olson, seconded by Rubenzer to recommend the Common Council approve the attached Preliminary Resolution Declaring Intent to Levy Special Assessments. All present voting aye. MOTION CARRIED.
- 4. Assistant City Engineer McElroy presented the attached 2021 Special Assessment Rates. He noted that he used historical values and recent contractor prices to determine the 2021 rates. He stated that he used typical and normal contractor prices when establishing rates. Motion by Rubenzer, seconded by Olson to recommend the Common Council approve the attached resolution for 2021 Special Assessment Rate. All present voting aye. MOTION CARRIED.

- 5. Assistant City Engineer McElroy presented the attached resolution for 2021 alley special charges. He noted that the alley front foot rate had increased from \$8.00 per alley front foot in 2020 to \$8.50 per alley front foot in 2021 due to expected asphalt price increases. Mayor Hoffman asked if any more downtown alleys were scheduled for repaving in 2021. Director of Public Works Rubenzer will discuss with staff and report back at a future Board meeting. Motion by Olson, seconded by Rubenzer to recommend the Common Council approve the attached resolution setting the special charge for alleys at \$8.50 per alley front foot for 2021. All present voting aye. MOTION CARRIED.
- 6. <u>Motion</u> by Olson, seconded by Bauer to adjourn. All present voting aye. <u>MOTION</u> <u>CARRIED</u>. The Board of Public Works meeting adjourned at 6:11 P.M.


The Board of Public Works met in City Hall on Monday, December 21, 2020 at 5:30 PM. The meeting was live streamed from the council room in City Hall. Attending remotely were Mayor Greg Hoffman, Director of Public Works Rick Rubenzer P.E., Finance Manager Lynne Bauer, Alderperson Paul Olson and Darrin Senn. Also attending remotely were Assistant City Engineer Bill McElroy P.E., Adam Bauer and Will Petska of Advanced Laser Company.

- 1. <u>Motion</u> by Olson, seconded by Bauer to approve the minutes of the December 7, 2020 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED.</u>
- 2. Will Petska and Adam Bauer presented a request for a pedestrian crosswalk and street light on Cashman Drive east of STH #178 on behalf of Advanced Laser. Mr. Petska stated that Advanced Lasers building on the southeast corner of STH #178 and Cashman Drive was a year old and employees were crossing Cashman Drive during all times of the day and night. There had been several near misses and Advanced Laser is very concerned for their employee safety at this crossing. Advanced Laser plans for future expansion and more pedestrians/employees will be crossing at the requested location. Director of Public Works Rubenzer noted that a similar request from Chippewa River Industries in Lake Wissota Business Park was previously granted. The city constructed a pedestrian crosswalk with appropriate signs and Chippewa River Industries constructed sidewalks approaching the crosswalk. He also noted there was an existing power pole about sixty feet from the proposed crosswalk location on Cashman Drive. The Board discussed a possibility of a flashing crosswalk sign. Assistant City Engineer McElroy stated such a sign was installed at Main Street and Park Avenue and estimated the cost was around fifteen thousand dollars. Alderperson Olson stated he thought Advanced Laser should be responsible for costs associated with a push-button flashing yellow pedestrian crosswalk sign, if chosen. Mr. Petska stated that the basic pedestrian crosswalk would be sufficient at this time. He stated Advanced Laser would be willing to construct an approach walk for the crossing and would consider parking lot lighting improvements. Alderperson Olson was concerned about the existing power pole being too far from the proposed crosswalk location and not being able to provide sufficient lighting. Director of Public Works Rubenzer stated Xcel Energy would need to be asked if a light arm could be added to the existing pole and what the cost would be, (100 watt or 150 watt LED light).

<u>Motion</u> by Rubenzer, seconded by Senn to recommend the Common Council approve the city installing a standard pedestrian crosswalk and signs on Cashman Drive approximately one hundred forty feet east of STH #178. All present voting aye. <u>MOTION CARRIED.</u> <u>Motion</u> by Rubenzer, seconded by Senn to recommend the Common Council approve the city installing a street light on an existing power pole approximately eighty feet east of the east right-of-way of STH #178 on the north side of Cashman Drive. All present voting aye. **MOTION CARRIED.**

3. <u>Motion</u> by Senn, seconded by Olson to adjourn. All present voting aye. <u>MOTION</u> CARRIED. The Board of Public Works meeting adjourned at 5:54 P.M.

It would appear to me that the opening of the alley to Birch Street in 1989 was improperly done as it needed to be done by petition and hearing under 62.22(4)(b). However, this failure is cured by 66.1033(2) which provides that if the proceedings were done before January 1, 2005 are inadequate they are cured if they were not challenged within 5 years of having been done. All the alley work in this area was done before January 1, 2005 and it has never been challenged. Therefore, the alley, as it exists, is legal. Bob.

Brad/Rick,

I dove down the rabbit hole in trying to figure out if that alley was real property or ROW and quite the rabbit hole it ended up being. Here is what I found...

- The alley between Birch and Willow was not originally platted in the Allen's Addition Plat. The only alley that existed at the time was the one between Bridge and Rushman.
- In 1989, Super America requested that the alley between Bridge and Rushman be partially vacated to the end of their property (at the time and how it is currently shown today). In order to maintain access to the alley, the City negotiated that the vacation of the alley was contingent upon Super America and Grothe (who I believed own the Lumberjack tool building at the time) quit claim the property to the City. The notes and minutes claim this was to be for "Replacement Alley Right of Way"
- The alley between Bridge and Rushman was vacated on April 18th, 1989 via resolution R-89-14. The Resolution makes no mention of dedicating a new alley right of way.
- Super America quit claimed their portion of the alley to the City on August 28th, 1989. Grothe quit claimed on Sept 20, 1989.
- The recorded deeds from Grothe and Super America do not mention it right of way on them, however the paper work for the real estate transfer indicates that the type of transfer as "other" with "other" being listed as "Dedication of Alley". Those deeds and paperwork are attached. I don't believe the paperwork that accompanies the deed is considered a recorded document. I found it with the hard copies in the basement. On the County's Laredo site it is not included.

Long story, short – I don't know if indicating "dedication of alley" on the paperwork is enough to officially dedicate an alley. I did not find any resolutions of the dedicated alley. I think Attorney Ferg should review, if this is the route we want to go (pending Brad & Scott's talk with Holiday).

Side note – the reason for the funny shaped parcel is to accommodate truck turns.

Pubic & Employee Safety vs Commerce

PROPOSED ALLEY CLOSURE

<u>Background:</u> The gas station was able to close two alleys from the West and North and with our proposed closure, their customers can still enter and exit from three options, Rushman Alley, Willow and Bridge St. Birch St alley was not properly done in 1989 and by default became an alley in 2005.

We believe our request is consistent, fair, reasonable and will have zero impact their sales. The gas station's three traffic options far exceed most other business. Our review shows, all business have one (BP) and some have two, (Express Mart) three is an exception (Family Fare, Quick Trip) and no others have four. We feel it is unreasonable and cannot be justified based on all other stores within the city and if all the others get by with 1, 2 or 3, why can't they? It is about safety and fairness and most importantly, we want their customers to have a great experience because we hope to capture some of them as well!

- 1. Safety of the forklift operator, truck drivers, employees and the cars entering or exiting
 - a. Blind corner and the doors open nearly right into traffic especially when they are not paying attention
 - b. On their phones while driving and not use to people using the building in this fashion for 25 years
 - c. No other tenant has used a forklift to load/unload there
 - d. Not use to employees or cars using that area 5 days/week, 10 hours/day the past 25 years.
 - e. Speed of cars entering and exiting too fast.
 - f. Almost ran into Wendy & I while walking around the building.
 - g. Almost ran into Tim Mower taking pictures and measuring the building
- 2. School bus parking requires your vehicle to past the centerline to see if cars are coming up Birch St
- 3. Woman riding up the street from Romis apartment in a wheelchair through the alley
- 4. Usage 80% leaving the gas station and 20% entering
- 5. Safer for forklift operations during winter months especially turning fresh snow into packed ice by morning
- 6. Minimizes frustration of a car trying to drive through while a truck is backing in and may get stuck because another vehicle is in line at the car wash.
- 7. Use bollards to restrict vehicle traffic yet is handicap acceptable and bike and foot traffic friendly
- 8. They still have 3 directions of entrance to the store

Recap: By discontinuing the alley we can have fairness within the city, and quickly eliminate any frustration by the change. I believe in the long run there will be more frustration with option 2 because the customers will never know is it open or closed. We are spending nearly \$750k to improve downtown and make up for lost tax revenue for the past 25 years on the building and all we are asking is for safety and fairness.

The question to be answered by discontinuing the alley is, are we making it safer for all or a convenience for some?

- Is it safer for our employees, truck drivers, forklift operators?
- Is it safer for the Holiday customers?
- Is it safer for the handicap coming from Romis on their scooters?
- Is it safer for pedestrians walking or riding a bike?
- Is it safer for those in queue at the car wash?
- Will it cause less stress when it is a constant closure versus random and not ever knowing if its closed or not?
- Is it safer and easier to create new traffic patterns when it constant?
- Random closures will have more of a customer impact versus consistently closed

Why keep it open and use the "speed bump" method?

- Snow plowing how many days a year does that impact them backing up the alley
- Perceived convenience for the customers until they are not able to access it consistently, randomly open will cause mush more frustration
- Because it has been this way for a couple decades

NO ALLEY CLOSURE - "SPEED BUMP/ELEVATION PAD"

- 1. Pad size approximately 25' radius with tapered edges, water drainage towards Birch St.
 - a. Collaborate the design with myself, Bill Larson and Rick Ruf. My input as a user, Bill from engineering and Rick from the street department.
- 2. Install 4 bollards (both ends of the alley) and use a yellow safety chain with "truck loading" sign attached.
- 3. To control speed and awareness Post signs "Speed Bump" "Watch for Forklift" "Watch for Pedestrian's."
- 4. Safer for forklift operations during winter months. Minimal elevation (~1') and will taper edges.
- 5. Easier for trucks to back into a lager pad area and forklift safety
- 6. Who is going to manage any "road rage" when a truck driver or gas station customer meet?

- 7. Remove existing driveways and replace them with concrete driveways in the public right of way
- 8. Removal and replacement of deficient street surfacing
- 9. Preparation for and construction of sidewalk where it does not currently exist and is deemed necessary

B. Irvine Street (Greenville Street to Summit Avenue)

- 2. Sanitary sewer services, from the main to the boulevard
- 3. Water main
