## CITY OF CHIPPEWA FALLS BOARD OF PUBLIC WORKS MEETING MINUTES MONDAY, SEPTEMBER 27, 2021 – 5:30 PM

The Board of Public Works met in City Hall on Monday, September 27, 2021 at 5:30 PM. Attending were Vice-President Tom Hubbard, Director of Public Works Rick Rubenzer P.E. and Finance Manager Lynne Bauer. Mayor Greg Hoffman and Alderperson Hayden Frey were absent.

- 1. <u>Motion</u> by Bauer, seconded by Rubenzer to approve the minutes of the September 13, 2021 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED</u>.
- 2. The Board of Public Works considered the attached State Municipal Maintenance Agreement for maintenance responsibilities in and around STH #124/Business #29 roundabout. Director of Public Works Rubenzer explained that this agreement formalized maintenance responsibilities for the STH #124/Business #29 roundabout and surrounding ponds and pedestrian underpass.
