The Board of Public Works met in City Hall on Monday, December 13, 2021 at 5:30 PM. Attending were Mayor Greg Hoffman, Tom Hubbard, Director of Public Works Rick Rubenzer P.E., Finance Manager Lynne Bauer and Alderperson Hayden Frey. Assistant City Engineer Bill McElroy also attended and those on the attached attendance roster.

1. <u>Motion</u> by Hubbard, seconded by Bauer to approve the minutes of the October 11, 2021 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED.</u>

<u>Motion</u> by Rubenzer, seconded by Hubbard to move item 3 to item 2. **All present voting aye.** <u>MOTION CARRIED.</u>

3. The Board of Public Works considered and discussed the request from the Willow Creek Masters Homeowners Association to restrict or prohibit parking on Northview Lane. Director of Public Works Rubenzer provided background information regarding the request. He indicated that Northview Lane narrows from 38 feet width to a 30 foot width as it turns north-south. Sander Englesgjerd, 1819 Luke Place, commented that when vehicles are parked on the street, visibility at the intersection is reduced and bi-directional traffic is not possible. Alan Alden, 1744 Timber Trail, agreed and added similar comments.

<u>Motion</u> by Hubbard, seconded by Rubenzer to recommend the Common Council amend Chippewa Falls Municipal Code 7.09 (1) (b) to prohibit parking on the north/east side of Northview Lane from Timber Trail to 280 feet to the southeast. **All present voting aye. MOTION CARRIED.**

- 2. The Board of Public Works considered and discussed the 2022-2026 Capital Improvement plan as presented in the attachments. Assistant City Engineer McElroy provided an overview and background information of the projects included in the 2022-2026 plan detailing changes and additions made from the previous plan. Mayor Hoffman inquired about how additional mileage could be added to the program. Assistant City Engineer McElroy responded that in the proposed plan included additional funding for non-structural overlays and that several projects within the proposed plan included full utility replacements which increases project overall cost and complexity.

 Motion by Hoffman, seconded by Rubenzer to recommend the Common Council approve the 2022-2026 Capital Improvement Plan as presented and accept the corresponding resolution. All present voting aye. MOTION CARRIED.
- 4. <u>Motion</u> by Hubbard, seconded by Bauer to adjourn. All present voting aye. <u>MOTION</u> <u>CARRIED.</u> The Board of Public Works meeting adjourned at 5:52 P.M.

The Board of Public Works met in City Hall on Monday, October 11, 2021 at 5:30 PM. Attending were Mayor Greg Hoffman, Vice-President Tom Hubbard, Director of Public Works Rick Rubenzer P.E. and Finance Manager Lynne Bauer. Alderperson Hayden Frey was absent.

- 1. <u>Motion</u> by Hubbard, seconded by Bauer to approve the minutes of the September 27, 2021 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED</u>.
- 2. The Board of Public Works considered the attached proposal from Dahlby Conservation Services LLC to provide comprehensive technical forestry services to aid in managing the City of Chippewa Falls Urban Forest. Director of Public Works Rubenzer noted that he had emailed a request for proposals to seven forestry management firms on September 24, 2021 and had only received the attached proposal. He highlighted the proposal items of planning a timber harvest operation consistent with DNR Silvicultural Handbook, that included marking the timber for harvest, bidding out the timber harvest, overseeing the timber contract and treatment of invasive species. Mr. Dahlby has estimated a market value no less than \$40,000 for the designated forests in the cities west well fields and wastewater farm in the Town of Wheaton. Director of Public Works Rubenzer noted that utility staff had reviewed and approved the proposal. Estimated charges for the proposal are\$20,030. All costs and income are for the Department of Public Utilities however Director of Public Works Rubenzer stated he may also solicit management of the non-utility owned city forests.

<u>Motion</u> by Hubbard, seconded by Rubenzer to recommend the Common Council accept the attached proposal from Dahlby Conservation Services LLC to provide comprehensive technical forestry services to aid in managing the City of Chippewa Falls Urban Forest. In addition, to authorize Mayor Hoffman to execute a corresponding agreement for the said services in the amount of \$20,030. **All present voting aye. MOTION CARRIED.**

3. <u>Motion</u> by Hubbard, seconded by Bauer to adjourn. All present voting aye. <u>MOTION</u> <u>CARRIED</u>. The Board of Public Works meeting adjourned at 5:37 P.M.

RE: Parking along Northview Lane at Timber Trail

Dear Sir or Madam:

The Willow Creek Master Homeowners Association, Inc. (WCMHOA) would like to address an issue that we believe is a safety problem. The Board of Directors of the WCMHOA has authorized me to bring this issue to your attention. The area of concern is at the intersection of Northview Lane and Timber Trail.

The safety issue concerns the width of Northylew Lane at this intersection and traveling east along Northylew Lane. Northylew Lane is 19 feet wide. This width continues east on Northylew Lane for approximately 125 feet. The road then widens beyond this point. If vehicles park on both sides of Northylew Lane in this area, two cars have difficulty safely passing each other. Larger vehicles, fire trucks, ambulances, City trucks, etc. cannot safely pass each other. This problem is made worse during the winter when snow is plowed back to the curbs.

Several Members of the WCMHOA that live north and south of this intersection use this intersection for normal egress from the WCMHOA. There is potential for additional housing north of Northview Lane which will only worsen this problem. The apartments (Townhomes) south of this intersection also use this intersection on a regular basis. The Board of the WCMHOA has received several complaints from members concerning this issue.

As a possible solution to this problem the WCMHOA is suggesting that parking be restricted on parts of Northview Lane from the intersection with Timber Trail traveling east on Northview Lane. If parking were restricted on the north side of Northview Lane to the driveway entrance for 834 & 836 Northview Lane and then again from the east terminus of that driveway to the sharp bend in the road (north side) this would help alleviate problems with the narrow road. This solution would lessen the number of restricted parking spaces. The WCMHOA would also entertain any other possible solution. Please refer to the map/diagram attached.

We are requesting that this issue be addressed by the Safety Committee and referred to the City Council for resolution. Mr. Alan Alden, 1744 Timber Trail, Chippewa Falls, WI, member of the WCMHOA, and I, 1819 Luke Place, Chippewa Falls, WI, Secretary, Board of Directors of the

We have copied in the affected landowners that adjoin this intersection. The houses on both the north and south sides of Northview Lane are rentals and owned by LLC's which rent all the units. We are hoping that all interested parties would address this issue as we seek a solution.




