

On June 12, 2023, the Plan Commission recommended that a corridor of Chippewa Mall Drive between vacated Woodhill Avenue and the Chippewa Crossing Boulevard roundabout be removed from the official map of the City of Chippewa Falls and a corridor of Chippewa Crossing Boulevard between STH #178 and 160<sup>th</sup> Street be added to the official map of the City of Chippewa Falls.

Following the Public Hearing concerning these amendments, the Common Council will consider adoption of Ordinance No. 2023-16 thereby removing a corridor of Chippewa Mall Drive between vacated Woodhill Avenue and the Chippewa Crossing Boulevard roundabout from the official map of the City of Chippewa Falls and Ordinance No. 2023-17 adding a corridor of Chippewa Crossing Boulevard between STH #178 and 160<sup>th</sup> Street be added to the official map of the City of Chippewa Falls.

### CITY OF CHIPPEWA FALLS BOARD OF PUBLIC WORKS MEETING MINUTES MONDAY, JULY 24, 2023 – 5:30 PM

The Board of Public Works met in City Hall on Monday, July 24, 2023 at 5:30 PM. Attending were Mayor Greg Hoffman, Interim Director of Public Works Bill McElroy, Finance Manager Lynne Bauer, Alderperson Jason Hiess and Tom Hubbard. Also attending was City Planner Brad Hentschel.

- 1. <u>Motion</u> by Hubbard, seconded by Hiess to approve the minutes of the June 12th, 2023 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED.</u>
- 2. The Board of Public Works considered the Stormwater Facility and Drainage Easement between the City of Chippewa Falls and Mason Companies on Outlot #1 of Certified Survey Map #4719. McElroy provided background on the stormwater facility noting that in the conditional stormwater permit approval dated August 9<sup>th</sup> 2021, the City was going to maintain the pond in exchange for the Mason Companies tilling compost into the regional infiltration basin. Since the city provided compost did not meet WDNR standards, Mason Companies opted to retain maintenance of the pond. Since the pond was on City property, an easement or sale of the property would be required. Hiess recommended that a certified survey map be created and the property be sold to Mason Companies instead of creating an easement as it helps to clarify ownership and maintenance duties.

<u>Motion</u> by Hiess, seconded by Hubbard to recommend the Common Council sell the parcel of land shown in the attached stormwater facility easement for \$1.00 contingent on the following:

- 1) The City of Chippewa Falls having the first right of refusal at the original purchase price
- 2) A certified survey map being created so the pond would be included with the existing Mason Companies lot
- 3) Successful closeout of the stormwater permit including an as-built
- 4) Review and approval by City of Chippewa Falls Engineering Department
- 5) Review and approval by Attorney Ferg
- 6) Mason Companies being responsible for all legal, surveying, recording, and other associated fees.

### All present voting aye. MOTION CARRIED.

- 3. The Board of Public Works considered the proposal from ISG for professional siphon analysis services at Duncan Creek. McElroy provided background on the two siphons indicating that they were constructed in 1939 and are utilized to transport wastewater underneath Duncan Creek. The analysis will provide repair and replacement options along with associated costs, feasibility, operations and maintenance.
  - <u>Motion</u> by Hubbard, seconded by Hiess to recommend the Common Council accept the proposal from ISG for professional siphon analysis at a cost of \$38,900 with the funds to come from the bond. All present voting aye. <u>MOTION CARRIED.</u>

# CITY OF CHIPPEWA FALLS BOARD OF PUBLIC WORKS MEETING MINUTES MONDAY, JUNE 12, 2023 – 5:30 PM

The Board of Public Works met in City Hall on Monday, June 12, 2023 at 5:30 PM. Attending were Mayor Greg Hoffman, Director of Public Works Rick Rubenzer P.E., Finance Manager Lynne Bauer Alderperson Jason Hiess and Tom Hubbard. City Engineer Bill McElroy also attended.

- 1. <u>Motion</u> by Hubbard, seconded by Bauer to approve the minutes of the May 08, 2023 Board of Public Works meeting. All present voting aye. <u>MOTION CARRIED.</u>
- 2. The Board of Public Works considered the Water Utilities entry into the safe drinking water loan program for replacement of water services with lead joint goosenecks in them. Director of Public Works Rubenzer handed out the attached supplemental letter agreement with S.E.H. The application is due June 30, 2023.
  - Motion by Hubbard, seconded by Hiess to recommend the Common Council approve the attached supplemental letter agreement with S.E.H. for the City of Chippewa Falls Water Utilities application and administration of a safe drinking water loan for lead gooseneck and service replacement. The agreement is for \$6000 for program application and \$22,000 for administration of the loan. Up to 50% of the loan may be principal forgiveness but it is unknown how much at this time. All present voting aye except Bauer who voted nay. MOTION CARRIED
- 3. Director of Public Works Rubenzer summarized the attached Real Estate Assessment form for WisDOT Documentation as it regards to Sojenhomer LLC vs Village of Egg Harbor decision and how it relates to WisDOT projects in the City of Chippewa Falls. He said due to the said court decision, WisDOT can no longer "condemn" for temporary limited easements or parcel acquisitions on WisDOT projects where new sidewalk construction or large replacement of sidewalks on projects are concerned. He stated that Right-of-Way Professionals who are performing acquisitions on STH #124 resurfacing projects and AECOM consulting engineers both agree that the City shouldn't have any sidewalks requiring condemnation on the STH #124 project. The forms stating such will need to be completed for each parcel and sent to WisDOT.

Motion by Hiess, seconded by Hubbard that the Common Council direct the Engineering Department to work with Right-of-Way Professionals to complete the Real Estate Assessment form for WisDOT Documentation as it regards to Sojenhomer LLC vs Village of Egg Harbor decision and how it relates to WisDOT projects in the City of Chippewa Falls for the STH #124 resurfacing projects currently scheduled for 2026. All present voting aye. MOTION CARRIED.

4. The Board of Public Works discussed the request from Karen Bushland and Dan Bushland representing Goeroke ETAL to revise an existing easement with Wolfgang on an existing City of Chippewa Falls owned driveway at the Nelson Road Landfill. The October 10, 2022 Board of Public Works considered three options as attached. At that time Ms. Bushland stated that Mr. Henning was not in favor of an access easement across his property (option #2). After the Board of Public Works meeting, the Village of Lake Hallie DENIED the request to detach triangular parcel #22809-1044-50050800. The easement was again considered by the December 12, 2022 Board of Public Works (minutes attached), and a recommendation to the

Common Council to allow the revision of the existing easement with Wolfgang was made and approved. After that, Director of Public Works Rubenzer received an email from Doug Clary of Chippewa County showing that there was an existing legal and viable easement across the Henning property and Director of Public Works Rubenzer learned that a possible split of the triangular lot, parcel #22809-1044-50050800 was also being considered. At that point it was again placed on the upcoming June 12, 2023 Board of Public Works agenda for discussion.

Motion by Hiess, seconded by Hubbard to reaffirm the previous Common Council discussion to allow revising of the existing Wolfgang easement with the condition that a deed restriction be placed on triangular lot, parcel #22809-1044-50050800 that prevented ANY future subdivision of the lot. All present voting aye. MOTION CARRIED.

- 5. The Board of Public Works considered the attached 2022 Compliance Maintenance Annual Report summary and corresponding approval resolution. Director of Public Works Rubenzer explained that the wrong application rate had been used for the past decade or so and a new WDNR staff person had discovered this in the review of the report. Using the said application rate resulted in over-applying Nitrogen to a 6.5 acre field in 2022 yielding an "F" in the biosolids part of the report. The application rate will be revised to a correct and acceptable amount moving forward. As noted on the resolution, two quarterly Molybdenum analyses exceeded 80% of the ceiling limit.
  - <u>Motion</u> by Hoffman, seconded by Rubenzer to recommend that the Common Council accept the 2022 Compliance Maintenance Annual Report and approve the corresponding resolution. All present voting aye. <u>MOTION CARRIED</u>.
- 6. City Engineer Bill McElroy presented the attached State Municipal Agreement for replacement of Central Street Bridge over Duncan Creek. The project is an 80% 20% split, so the federal share would be \$2,596,480 and the City share would be \$649,620 and the project is currently scheduled for 2027. Design of the bridge would occur between 2023 and 2027 and cost approximately \$375,200 with a local share of \$75,040 for the said design.
  Motion
  by Hubbard, seconded by Rubenzer to recommend the Common Council approve the State Municipal Agreement for replacement of Central Street Bridge over Duncan Creek and authorize Mayor Hoffman to execute the same. All present voting aye. MOTION
  CARRIED.
- 7. Motion by Hubbard, seconded by Hiess to adjourn. All present voting aye. MOTION CARRIED. The Board of Public Works meeting adjourned at 6:20 P.M.



Commencing at the Northwest corner of said Section 33, Township 29 North, Range 8 West; thence N 89°50′49″ E, 50.01 feet, to the easterly right-of-way line of Commerce Parkway, also being the point of beginning; thence N 00°44′46″ E, along said easterly right-of-way line of Commerce Parkway, a distance of 104.57 feet; thence N 89°55′54″ E, a distance of 213.13 feet; thence S 60°44′38″ E, 246.80 feet; thence S 00°48′59″ W, a distance of 199.15 feet to the South line of said Outlot 1, Certified Survey Map No. 4719; thence S 89°55′54″ W, along the north line of the Northwest 1/4 of said Section 33, a distance of 430.05 feet to said easterly right-of-way line of Commerce Parkway; thence N 00°48′59″ E, along said easterly right-of-way line of Commerce Parkway, a distance of 215.47 feet to the point of beginning. ### PARTIES TO THE AGREEMENT

The City of Chippewa Falls, a Wisconsin municipal corporation ("Grantor"), as the owner of the Storm Water Facility ea, has provided Mason Companies, Inc., a Wisconsin corporation, together with its successors in interest thereto, Grantee"), with a Storm Water Facility and Drainage Easement ("Easement") that includes certain real property including the Storm Water Facility Area.

### PERMANENT COMPONENTS OF THE STORM WATER SYSTEM

Pursuant to the Easement, Grantee is entitled to construct a storm water system within the Storm Water Facility Area ("Storm Water Facility") with the following components:

- 1. Storm sewer pipes and culverts; and
- 2. Storm water wet pond and outlet structures.


### MAINTENANCE AND REPAIR

Grantee shall twice annually (spring and fall) inspect the Storm Water Facility. Grantee shall be responsible for performing all maintenance and repairs to the Storm Water Facility as recommended by Grantee's retained storm water facilities professional with said recommendations being consistent with the applicable provisions of the Wisconsin Administrative Code and local storm water ordinances as enacted at the time of execution of this document. Every 5th year, the Storm Water Facility shall be evaluated for sediment accumulation. When the depth of the permanent pool decreases by more than 3.5 feet from the original construction depth, the accumulated sediment shall be removed to a level 3-6 inches above the designed pool bottom to protect the liner. Dredged materials shall be disposed of according to applicable laws. Dredging is not anticipated to occur any more frequently than 40 year intervals. Any mowing within buffer areas, pond banks, and drainage ways will be minimized in order to maximize the infiltration of runoff. To the extent mowing is ever needed, the mowing height will be no shorter than six (6) inches. Application of fertilizers, herbicides, pesticides, or other chemical applications are prohibited within buffer as, pond banks, and along drainage ways. Grantee shall be responsible for retaining all inspection and maintenance records as required by law and shall file said Storm Water Facility inspection and maintenance records with Grantor. Notwithstanding the foregoing, in the event that any maintenance and/or repair is required as a result of the of the action of Grantor, or a party authorized by Grantor, Grantor shall be solely responsible for the cost of said maintenance and/or repairs.

### SPECTION AND ACTION BY GRANTOR

Granter shall have access to the Storm Water Facility Area to conduct inspections as necessary to confirm that Grantee is performing its obligations pursuant to the terms as set forth herein. In the event Granter determines that Grantee has not performed its obligations pursuant to the terms as set forth herein, Granter shall promptly provide Grantee with written notice of said nonperformance violation with at least a thirty (30) day right to cure (longer if required due to weather or scope of required work). Thereafter, if Grantee has not completed said required work, Granter may perform said required work and assess all associated costs to Grantee pursuant to Wisconsin State Statutes.

All stormwater management and erosion control activities undertaken at the site must be done in accordance with the terms of the approved plans and conditions listed below:

### To be addressed prior to construction beginning:

- 1. Provide the City with the full HydroCad report for the "north pond" including the full build outs of Mills Fleet Farm/DHL and HPE/DHL site.
- 2. This site must secure all other State and Local permits as necessary before commencing construction. Driveway and street opening permits will be required from the City of Chippewa Falls Engineering office.
- 3. Provide the phone number and email address to the City of Chippewa Falls of the individual responsible for erosion control and stormwater management during construction (contractor and inspector, if different).
- 4. The erosion control permit fee and the storm water management fee (Invoice 21-02 attached) must be paid before any construction commences. The fees will be as follows:
  - a. Storm Water Management Permit: \$50 + (\$2/1000 SF Impervious Area) = \$50 + 740,520 sf (\$2/1000 sf) = \$1531.04
  - b. Erosion Control Permit: \$50 + (\$2/1000 SF Disturbed Area) = \$50 + 1,450,548 sf (\$2/1000 sf) = \$2951.10
- 5. Invite the City of Chippewa Falls to the preconstruction meeting in order to discuss any stormwater related issues and receive a schedule for the project.
- 6. Provide the City with the most up to date plan set. This plan set should include the valves and pipe needed to relocate the hydrant on the south side of the property.

### To be addressed during construction:

- 1. A copy of the approved Storm Water Management & Erosion Control Plan shall be provided to the selected contractor. The approved plans should be available at all times on site and be presented upon request of representatives of the City of Chippewa Falls.
- 2. Erosion and sediment controls are inspected at least every 7 days, and within 24 hours after a rainfall event of 0.5 inches or greater. Weekly written reports of all inspections must be maintained and made available upon request.

In addition, the reports shall be emailed upon their completion to Bill McElroy (bincelroy@chippewafallswi.gov). The reports must contain the following:

- a. Date, Time, and location of inspection,
- b. Name (s) of individual (s) performing the inspection.
- c. Current phase of construction.
- d. Assessment of the condition of erosion and sediment and maintenance control activities.
- 3. Notify Chippewa Falls Engineering staff three days (3) prior to connecting to City Infrastructure (Storm, Water, Wastewater). Please notify the Chippewa Falls Water Department 48-Hours prior to any required modifications or required operation of the Chippewa Falls municipal water system. Only Chippewa Falls Water Department Staff can operate valves.
- 4. Soil tests confirming the clay liner in the wet ponds meets the WDNR standards for a Type A liner shall be submitted to the Chippewa Falls Engineering office.
- 5. In exchange for the City allowing for a wet detention pond which only serves the site to be built on City owned property, the Owner has agreed to till in 2-inches of compost into the floor of the existing infiltration basin located on parcel 2025,5053 to act as a filtering layer, The City will provide the compost at no cost, but the Owner of the site is required to have the provided compost tested to ensure it meets the standards and recommendations of the Wisconsin Department of Natural Resources. If the compost does not meet the standards and recommendations, the Owner will either remediate the compost at their cost or retain maintenance of the proposed pond located on City property. The Owner will be responsible for the hauling and loading of the compost from the City Shop location at 5 Bjork-Riverside Drive, The compost will not be ready for transport until April 1, 2022 due to necessary screening of the material that will need to occur over the Fall and Winter months,

### To be addressed post construction (to facilitate permit closeout):

- 1. When construction activities are completed, and the site has undergone final stabilization, a written notification shall be filed with the City of Chippewa Falls Engineering Office noting the project is complete and that the site was built according to the approved plan. The letter shall be sealed by the submitting engineer. Once notified that the project is complete, a walk through with a City Representative shall be scheduled to review the project. One particular item to note on this project will be that the storm manholes in the easement on the northeast side of the project were properly adjusted and not damaged during construction.
- 2. As-builts of the utilities and stormwater facilities shall be provided to the City of Chippewa Falls. The as-builts must be signed and stamped by the submitting engineer. The as-builts shall note which facilities are private and which facilities are public. CAD as-builts shall be provided for the facilities which will be maintained by the City of Chippewa Falls.
- 3. Provide the contact information for the owner of all private stormwater facilities.
- 4. A maintenance agreement meeting conditions set forth in the Chippewa Falls Code of Ordinances 31.11 shall be recorded with Chippewa County. The approved, recorded document shall be submitted to the Chippewa Falls Engineering Office upon said recording. All maintenance agreements must be completed and recorded prior to final site acceptance.

It shall be noted that only Phase 1 of the project is approved. Future phases will need to review the entire site for compliance as a common plan for development.





# **WORK PROGRAM**

# FIELD EXPLORATION + EXISTING CONDITION ANALYSIS

An initial site visit and project kickoff with City staff will verify our understanding of the site and project requirements. The kickoff will consist of the following:

- Review existing siphon sites with City
- Discuss alternative methods to assist in determining siphon pipe issue for the River Street siphon and assist the City if they would like to pursue a method
- Determine if flow monitoring at siphon sites is necessary to confirm existing estimated flow for two siphon sites

ISG will review existing record plans, televising information, and documentation of events at both siphon sites. The team will also review existing sewer watersheds for both siphon sites and existing capacity. ISG will perform a topographic survey and field verification of existing conditions based on the findings of the topographic survey.

If additional investigation is needed, ISG will coordinate with the City's selected subcontractor as needed.

### PRELIMINARY ENGINEERING REPORT

Our team will prepare a preliminary engineering report to assess the condition of the siphons by reviewing the Wisconsin Department of Natural Resources and Wisconsin State Code requirements for siphon stream crossings. ISG will meet with the City to discuss any plans for growth for the two siphon sewer watersheds. This includes meeting with Leinenkugel Brewing Company, if needed, to determine any expansion plans for the Jefferson Avenue siphon site. The report will incorporate potential growth, if any, and determine required capacity of siphon site locations. This will confirm whether existing siphons are sized properly.

The project team will evaluate repair options for existing siphons, replacement options for siphon, and associated costs, feasibility, operations, and maintenance. During this task, we will consider alternative methods for stream crossings at siphon sites such as a lift station and forcemain. For each option, the team will determine if any in-utility modifications need to be accounted for and if additional right-of-way or easements are needed. The team will then review and summarize funding alternatives and necessary permits required for pertinent regulatory agencies.

### Preliminary Environmental Review

ISG's environmental scientists and engineers will review existing environmental information and documents provided by the City as well as any publicly available data in the vicinity of the project to determine if there is potential for environmental impacts to project areas. 

# Siphon Analysis + Outfall Lines Livermore, IA



The City of Livermore, Iowa had been experiencing surcharging of the sanitary sewer, sewer backups into basements, and bypassing of untreated sewage during high rainfall events for years. For 10 years, the City had undertaken multiple projects to reduce and eliminate the amount of Inflow and Infiltration (I&I) within their sewer collection network. Although they had success with reducing their peak flows, problems still existed.

The City engaged ISG to complete a study on how to eliminate the backups and bypassing. A review of the outfall lines to the lagoons was conducted and it revealed that the peak wastewater flows were substantially higher than the capacity of the outfall lines. A creative solution was proposed which not only provided an adequate outfall line that could handle the City's peak flow but also saved the City in costs for an additional outfall line to the lagoon for half of the town.

The City received a CDBG Disaster Assistance grant to cover all improvement costs and has since eliminated sewage bypassing, basement backups, and surcharging for their residents.

### City Sanitary Sewer Siphon Winthrop, MN

The City of Winthrop is undergoing a series of replacements and improvements along Highway 19, a major roadway that runs through the city. Minnesota Department of Transportation (MnDOT) plans to replace a culvert crossing for Sibley County Ditch 42 under the highway triggered the need to relocate an existing sanitary sewer siphon under the ditch.

### City of Cherokee Siphon Analysis Cherokee, IA

The City of Cherokee requested ISG to investigate their two siphons that cross the Little Sioux River. One siphon conveyed sewage from the City's industrial park, ISG reviewed installing a lift station at the siphon location and the South Cherokee lift station that served several businesses to best serve as a solution. The South Cherokee lift station was considered a better option as the infrastructure was already in place, and the City could relocate the outlet to either a new wastewater treatment plant or the second siphon that crosses the Little Sioux River, directly to their existing wastewater treatment plant.

The existing lift station was in fair condition, however, equipment and controls are starting to approach the end of their life. This would replace the equipment and controls for the lift station and reroute the forcemain to eliminate the need for the second siphon under the Little Sioux River. The City is currently designing improvements to its Beech Street lift station where the current siphon outlets to. This would also benefit this lift station as it is the City's largest lift station, reducing flow and costs.

The proposed option will improve the South Cherokee lift station and relocate the forcemain outlet to the City's current industrial wastewater treatment plant. The City is evaluating whether to make improvements to their current wastewater treatment plant or replace the plant, which will determine if the South Cherokee lift station will discharge to the new plant or utilize the other siphon, which would convey directly to the plant. This effort and project will eliminate the deficient siphon, overall saving the City time, effort, and costs.



## RESOLUTION NO. <u>202</u>3-36

## RESOLUTION AWARDING THE SALE OF \$3,765,000 GENERAL OBLIGATION CORPORATE PURPOSE BONDS, SERIES 2023C

WHEREAS, on June 20, 2023, the Common Council of the City of Chippewa Falls, Chippewa County, Wisconsin (the "City") adopted, by at least a 3/4 vote, initial resolutions authorizing the issuance of general obligation bonds in the following not to exceed amounts and for the following public purposes: \$1,185,000 for street improvement projects and \$505,000 for sewerage projects, consisting of storm sewer projects (collectively, the above-referenced initial resolutions are referred to herein as the "Project Initial Resolutions");

WHEREAS, on June 20, 2023 the Common Council of the City also adopted an initial resolution authorizing the issuance of general obligation refunding bonds (the "Refunding Initial Resolution");

WHEREAS, the obligation to be refunded is the Taxable General Obligation Promissory Note, Series 2023A, dated on or around July 27, 2023 (the "Refunded Obligations") (hereinafter the refinancing of the Refunded Obligations shall be referred to as the "Refunding");

WHEREAS, pursuant to the provisions of Section 67.05, Wisconsin Statutes, within 15 days following the adoption of the Project Initial Resolutions, the City Clerk caused a notice to electors to be published in the Chippewa Herald, stating the purpose and maximum principal amount of the bond issues authorized by the Project Initial Resolutions and describing the opportunity and procedure for submitting a petition requesting a referendum on the bond issues, authorized by the Project Initial Resolutions;

WHEREAS, no petition for referendum was filed with the City Clerk, and the time to file such a petition has expired;

WHEREAS, on June 20, 2023, the Common Council of the City also adopted a resolution (the "Set Sale Resolution"), providing that the general obligation bond issues authorized by the Project Initial Resolutions and the Refunding Initial Resolution be combined, issued and sold as a single issue of bonds designated as "General Obligation Corporate Purpose Bonds" (the "Bonds") for the purpose of paying the cost of the Project and the Refunding;

WHEREAS, the Common Council hereby finds and determines that the projects described in the Project Initial Resolutions (the "Project") are within the City's power to undertake and therefore serve a "public purpose" as that term is defined in Section 67.04(1)(b), Wisconsin Statutes;

WHEREAS, the Common Council deems it to be necessary, desirable and in the best interest of the City to refund the Refunded Obligations for the purpose of providing permanent financing for the projects financed by the Refunded Obligations;

WHEREAS, the City is authorized by the provisions of Section 67.04, Wisconsin Statutes, to borrow money and issue general obligation bonds for such public purposes and to refinance its outstanding obligations;

WHEREAS, pursuant to the Set Sale Resolution, the City has directed Ehlers & Associates, Inc. ("Ehlers") to take the steps necessary to sell the Bonds to pay the cost of the Project and the Refunding;

WHEREAS, Ehlers, in consultation with the officials of the City, prepared a Notice of Sale (a copy of which is attached hereto as Exhibit A and incorporated herein by this reference) setting forth the details of and the bid requirements for the Bonds and indicating that the Bonds would be offered for public sale on August 1, 2023;

WHEREAS, the City Clerk (in consultation with Ehlers) caused a form of notice of the sale to be published and/or announced and caused the Notice of Sale to be distributed to potential bidders offering the Bonds for public sale on August 1, 2023;

WHEREAS, the City has duly received bids for the Bonds as described on the Bid Tabulation attached hereto as <u>Exhibit B</u> and incorporated herein by this reference (the "Bid Tabulation");

WHEREAS, it has been determined that the bid proposal (the "Proposal") submitted by the financial institution listed first on the Bid Tabulation fully complies with the bid requirements set forth in the Notice of Sale and is deemed to be the most advantageous to the City. Ehlers has recommended that the City accept the Proposal. A copy of said Proposal submitted by such institution (the "Purchaser") is attached hereto as <a href="Exhibit C">Exhibit C</a> and incorporated herein by this reference; and

WHEREAS, the Common Council now deems it necessary, desirable and in the b	est
interest of the City that the Bonds be issued in the aggregate principal amount of \$	
for the following purposes and in the following amounts: \$ for street	et
improvement projects; \$ for sewerage projects, consisting of storm	sewer
projects; and \$ for the Refunding.	

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City that:

Section 1. Ratification of the Notice of Sale and Offering Materials. The Common Council hereby ratifies and approves the details of the Bonds set forth in Exhibit A attached hereto as and for the details of the Bonds. The Notice of Sale and any other offering materials prepared and circulated by Ehlers are hereby ratified and approved in all respects. All actions taken by officers of the City and Ehlers in connection with the preparation and distribution of the Notice of Sale, and any other offering materials are hereby ratified and approved in all respects.

Section 1A. Authorization and Award of the Bonds. For the purpose of paying the cost of the Project and the Refunding, there shall be borrowed pursuant to Section 67.04, Wisconsin Statutes, the principal sum of THREE MILLION SEVEN HUNDRED SIXTY-FIVE THOUSAND DOLLARS (\$3,765,000) from the Purchaser in accordance with the terms and

conditions of the Proposal. The Proposal of the Purchaser offering to purchase the Bonds for the sum set forth on the Proposal, plus accrued interest to the date of delivery, resulting in a true interest cost as set forth on the Proposal, is hereby accepted. The Mayor and City Clerk or other appropriate officers of the City are authorized and directed to execute an acceptance of the Proposal on behalf of the City. The good faith deposit of the Purchaser shall be applied in accordance with the Notice of Sale, and any good faith deposits submitted by unsuccessful bidders shall be promptly returned. The Bonds shall bear interest at the rates set forth on the Proposal.

Section 2. Terms of the Bonds. The Bonds shall be designated "General Obligation Corporate Purpose Bonds, Series 2023C"; shall be issued in the aggregate principal amount of \$3,765,000; shall be dated August 22, 2023; shall be in the denomination of \$5,000 or any integral multiple thereof; shall be numbered R-1 and upward; and shall bear interest at the rates per annum and mature on the dates and in the principal amounts as set forth on the Pricing Summary attached hereto as Exhibit D-1 and incorporated herein by this reference. Interest shall be payable semi-annually on June 1 and December 1 of each year commencing on June 1, 2024. Interest shall be computed upon the basis of a 360-day year of twelve 30-day months and will be rounded pursuant to the rules of the Municipal Securities Rulemaking Board. The schedule of principal and interest payments due on the Bonds is set forth on the Debt Service Schedule attached hereto as Exhibit D-2 and incorporated herein by this reference (the "Schedule").

Section 3. Redemption Provisions. The Bonds maturing on December 1, 2033 and thereafter shall be subject to redemption prior to maturity, at the option of the City, on December 1, 2032 or on any date thereafter. Said Bonds shall be redeemable as a whole or in part, and if in part, from maturities selected by the City, and within each maturity by lot, at the principal amount thereof, plus accrued interest to the date of redemption.

[The Proposal specifies that [some of] the Bonds shall be subject to mandatory redemption. The terms of such mandatory redemption are set forth on an attachment hereto as <a href="Exhibit MRP"><u>Exhibit MRP</u></a> and incorporated herein by this reference. Upon the optional redemption of any of the Bonds subject to mandatory redemption, the principal amount of such Bonds so redeemed shall be credited against the mandatory redemption payments established in <a href="Exhibit MRP"><u>Exhibit MRP</u></a> for such Bonds in such manner as the City shall direct.]

<u>Section 4. Form of the Bonds</u>. The Bonds shall be issued in registered form and shall be executed and delivered in substantially the form attached hereto as <u>Exhibit E</u> and incorporated herein by this reference.

#### Section 5. Tax Provisions.

(A) Direct Annual Irrepealable Tax Levy. For the purpose of paying the principal of and interest on the Bonds as the same becomes due, the full faith, credit and resources of the City are hereby irrevocably pledged, and there is hereby levied upon all of the taxable property of the City a direct annual irrepealable tax in the years 2023 through 2042 for the payments due in the years 2024 through 2043 in the amounts set forth on the Schedule.

(B) Tax Collection. So long as any part of the principal of or interest on the Bonds remains unpaid, the City shall be and continue without power to repeal such levy or obstruct the collection of said tax until all such payments have been made or provided for. After the issuance of the Bonds, said tax shall be, from year to year, carried onto the tax roll of the City and collected in addition to all other taxes and in the same manner and at the same time as other taxes of the City for said years are collected, except that the amount of tax carried onto the tax roll may be reduced in any year by the amount of any surplus money in the Debt Service Fund Account created below.

(C) Additional Funds. If at any time there shall be on hand insufficient funds from the aforesaid tax levy to meet principal and/or interest payments on said Bonds when due, the requisite amounts shall be paid from other funds of the City then available, which sums shall be replaced upon the collection of the taxes herein levied.

## Section 6. Segregated Debt Service Fund Account.

(A) Creation and Deposits. There shall be and there hereby is established in the treasury of the City, if one has not already been created, a debt service fund, separate and distinct from every other fund, which shall be maintained in accordance with generally accepted accounting principles. Debt service or sinking funds established for obligations previously issued by the City may be considered as separate and distinct accounts within the debt service fund.

Within the debt service fund, there hereby is established a separate and distinct account designated as the "Debt Service Fund Account for General Obligation Corporate Purpose Bonds, Series 2023C, dated August 22, 2023" (the "Debt Service Fund Account") and such account shall be maintained until the indebtedness evidenced by the Bonds is fully paid or otherwise extinguished. There shall be deposited into the Debt Service Fund Account (i) all accrued interest received by the City at the time of delivery of and payment for the Bonds; (ii) any premium not used for the Refunding which may be received by the City above the par value of the Bonds and accrued interest thereon; (iii) all money raised by the taxes herein levied and any amounts appropriated for the specific purpose of meeting principal of and interest on the Bonds when due; (iv) such other sums as may be necessary at any time to pay principal of and interest on the Bonds when due; (v) surplus monies in the Borrowed Money Fund as specified below; and (vi) such further deposits as may be required by Section 67.11, Wisconsin Statutes.

(B) Use and Investment. No money shall be withdrawn from the Debt Service Fund Account and appropriated for any purpose other than the payment of principal of and interest on the Bonds until all such principal and interest has been paid in full and the Bonds canceled; provided (i) the funds to provide for each payment of principal of and interest on the Bonds prior to the scheduled receipt of taxes from the next succeeding tax collection may be invested in direct obligations of the United States of America maturing in time to make such payments when they are due or in other investments permitted by law; and (ii) any funds over and above the amount of such principal and interest payments on the Bonds may be used to reduce the next succeeding tax levy, or may, at the option of the City, be invested by purchasing the Bonds as permitted by and subject to Section 67.11(2)(a), Wisconsin Statutes, or in permitted municipal investments under the pertinent provisions of the Wisconsin Statutes ("Permitted

Investments"), which investments shall continue to be a part of the Debt Service Fund Account. Any investment of the Debt Service Fund Account shall at all times conform with the provisions of the Internal Revenue Code of 1986, as amended (the "Code") and any applicable Treasury Regulations (the "Regulations").

(C) Remaining Monies. When all of the Bonds have been paid in full and canceled, and all Permitted Investments disposed of, any money remaining in the Debt Service Fund Account shall be transferred and deposited in the general fund of the City, unless the Common Council directs otherwise.

Section 7. Proceeds of the Bonds; Segregated Borrowed Money Fund. The proceeds of the Bonds (the "Bond Proceeds") (other than any premium not used for the Refunding and accrued interest which must be paid at the time of the delivery of the Bonds into the Debt Service Fund Account created above) shall be deposited into a special fund (the "Borrowed Money Fund") separate and distinct from all other funds of the City and disbursed solely for the purpose or purposes for which borrowed. Monies in the Borrowed Money Fund may be temporarily invested in Permitted Investments. Any monies, including any income from Permitted Investments, remaining in the Borrowed Money Fund after the purpose or purposes for which the Bonds have been issued have been accomplished, and, at any time, any monies as are not needed and which obviously thereafter cannot be needed for such purpose(s) shall be deposited in the Debt Service Fund Account.

Section 8. No Arbitrage. All investments made pursuant to this Resolution shall be Permitted Investments, but no such investment shall be made in such a manner as would cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Code or the Regulations and an officer of the City, charged with the responsibility for issuing the Bonds, shall certify as to facts, estimates, circumstances and reasonable expectations in existence on the date of delivery of the Bonds to the Purchaser which will permit the conclusion that the Bonds are not "arbitrage bonds," within the meaning of the Code or Regulations.

Section 9. Compliance with Federal Tax Laws. (a) The City represents and covenants that the projects financed by the Bonds and by the Refunded Obligations and the ownership, management and use of the projects will not cause the Bonds or the Refunded Obligations to be "private activity bonds" within the meaning of Section 141 of the Code. The City further covenants that it shall comply with the provisions of the Code to the extent necessary to maintain the tax-exempt status of the interest on the Bonds including, if applicable, the rebate requirements of Section 148(f) of the Code. The City further covenants that it will not take any action, omit to take any action or permit the taking or omission of any action within its control (including, without limitation, making or permitting any use of the proceeds of the Bonds) if taking, permitting or omitting to take such action would cause any of the Bonds to be an arbitrage bond or a private activity bond within the meaning of the Code or would otherwise cause interest on the Bonds to be included in the gross income of the recipients thereof for federal income tax purposes. The City Clerk or other officer of the City charged with the responsibility of issuing the Bonds shall provide an appropriate certificate of the City certifying that the City can and covenanting that it will comply with the provisions of the Code and Regulations.

- (b) The City also covenants to use its best efforts to meet the requirements and restrictions of any different or additional federal legislation which may be made applicable to the Bonds provided that in meeting such requirements the City will do so only to the extent consistent with the proceedings authorizing the Bonds and the laws of the State of Wisconsin and to the extent that there is a reasonable period of time in which to comply.
- Section 10. Designation as Qualified Tax-Exempt Obligations. The Bonds are hereby designated as "qualified tax-exempt obligations" for purposes of Section 265 of the Code, relating to the ability of financial institutions to deduct from income for federal income tax purposes, interest expense that is allocable to carrying and acquiring tax-exempt obligations.

Section 11. Execution of the Bonds; Closing; Professional Services. The Bonds shall be issued in printed form, executed on behalf of the City by the manual or facsimile signatures of the Mayor and City Clerk, authenticated, if required, by the Fiscal Agent (defined below), sealed with its official or corporate seal, if any, or a facsimile thereof, and delivered to the Purchaser upon payment to the City of the purchase price thereof, plus accrued interest to the date of delivery (the "Closing"). The facsimile signature of either of the officers executing the Bonds may be imprinted on the Bonds in lieu of the manual signature of the officer but, unless the City has contracted with a fiscal agent to authenticate the Bonds, at least one of the signatures appearing on each Bond shall be a manual signature. In the event that either of the officers whose signatures appear on the Bonds shall cease to be such officers before the Closing, such signatures shall, nevertheless, be valid and sufficient for all purposes to the same extent as if they had remained in office until the Closing. The aforesaid officers are hereby authorized and directed to do all acts and execute and deliver the Bonds and all such documents, certificates and acknowledgements as may be necessary and convenient to effectuate the Closing. The City hereby authorizes the officers and agents of the City to enter into, on its behalf, agreements and contracts in conjunction with the Bonds, including but not limited to agreements and contracts for legal, trust, fiscal agency, disclosure and continuing disclosure, and rebate calculation services. Any such contract heretofore entered into in conjunction with the issuance of the Bonds is hereby ratified and approved in all respects.

Section 12. Payment of the Bonds; Fiscal Agent. The principal of and interest on the Bonds shall be paid by Bond Trust Services Corporation, Roseville, Minnesota, which is hereby appointed as the City's registrar and fiscal agent pursuant to the provisions of Section 67.10(2), Wisconsin Statutes (the "Fiscal Agent"). The City hereby authorizes the Mayor and City Clerk or other appropriate officers of the City to enter into a Fiscal Agency Agreement between the City and the Fiscal Agent. Such contract may provide, among other things, for the performance by the Fiscal Agent of the functions listed in Wis. Stats. Sec. 67.10(2)(a) to (j), where applicable, with respect to the Bonds.

Section 13. Persons Treated as Owners; Transfer of Bonds. The City shall cause books for the registration and for the transfer of the Bonds to be kept by the Fiscal Agent. The person in whose name any Bond shall be registered shall be deemed and regarded as the absolute owner thereof for all purposes and payment of either principal or interest on any Bond shall be made only to the registered owner thereof. All such payments shall be valid and effectual to satisfy and discharge the liability upon such Bond to the extent of the sum or sums so paid.

Any Bond may be transferred by the registered owner thereof by surrender of the Bond at the office of the Fiscal Agent, duly endorsed for the transfer or accompanied by an assignment duly executed by the registered owner or his attorney duly authorized in writing. Upon such transfer, the Mayor and City Clerk shall execute and deliver in the name of the transferee or transferees a new Bond or Bonds of a like aggregate principal amount, series and maturity and the Fiscal Agent shall record the name of each transferee in the registration book. No registration shall be made to bearer. The Fiscal Agent shall cancel any Bond surrendered for transfer.

The City shall cooperate in any such transfer, and the Mayor and City Clerk are authorized to execute any new Bond or Bonds necessary to effect any such transfer.

Section 14. Record Date. The 15th day of the calendar month next preceding each interest payment date shall be the record date for the Bonds (the "Record Date"). Payment of interest on the Bonds on any interest payment date shall be made to the registered owners of the Bonds as they appear on the registration book of the City at the close of business on the Record Date.

Section 15. Utilization of The Depository Trust Company Book-Entry-Only System. In order to make the Bonds eligible for the services provided by The Depository Trust Company, New York, New York ("DTC"), the City agrees to the applicable provisions set forth in the Blanket Issuer Letter of Representations, which the City Clerk or other authorized representative of the City is authorized and directed to execute and deliver to DTC on behalf of the City to the extent an effective Blanket Issuer Letter of Representations is not presently on file in the City Clerk's office.

Section 16. Payment of Issuance Expenses. The City authorizes the Purchaser to forward the amount of the proceeds of the Bonds allocable to the payment of issuance expenses to a financial institution selected by Ehlers at Closing for further distribution as directed by Ehlers.

Section 17. Official Statement. The Common Council hereby approves the Preliminary Official Statement with respect to the Bonds and deems the Preliminary Official Statement as "final" as of its date for purposes of SEC Rule 15c2-12 promulgated by the Securities and Exchange Commission pursuant to the Securities and Exchange Act of 1934 (the "Rule"). All actions taken by officers of the City in connection with the preparation of such Preliminary Official Statement and any addenda to it or final Official Statement are hereby ratified and approved. In connection with the Closing, the appropriate City official shall certify the Preliminary Official Statement and any addenda or final Official Statement. The City Clerk shall cause copies of the Preliminary Official Statement and any addenda or final Official Statement to be distributed to the Purchaser.

Section 18. Undertaking to Provide Continuing Disclosure. The City hereby covenants and agrees, for the benefit of the owners of the Bonds, to enter into a written undertaking (the "Undertaking") if required by the Rule to provide continuing disclosure of certain financial information and operating data and timely notices of the occurrence of certain events in accordance with the Rule. The Undertaking shall be enforceable by the owners of the Bonds or

by the Purchaser on behalf of such owners (provided that the rights of the owners and the Purchaser to enforce the Undertaking shall be limited to a right to obtain specific performance of the obligations thereunder and any failure by the City to comply with the provisions of the Undertaking shall not be an event of default with respect to the Bonds).

To the extent required under the Rule, the Mayor and City Clerk, or other officer of the City charged with the responsibility for issuing the Bonds, shall provide a Continuing Disclosure Certificate for inclusion in the transcript of proceedings, setting forth the details and terms of the City's Undertaking.


Section 19. Redemption of the Refunded Obligations. The Refunded Obligations are hereby called for prior payment and redemption on August 23, 2023, or as soon as administratively possible thereafter, at a price of par plus accrued interest to the date of redemption.

The City hereby directs the City Clerk to take all actions necessary for the redemption of the Refunded Obligations on their redemption date. Any and all actions heretofore taken by the officers and agents of the City to effectuate such redemption are hereby ratified and approved.

Section 20. Record Book. The City Clerk shall provide and keep the transcript of proceedings as a separate record book (the "Record Book") and shall record a full and correct statement of every step or proceeding had or taken in the course of authorizing and issuing the Bonds in the Record Book.


Section 21. Bond Insurance. If the Purchaser determines to obtain municipal bond insurance with respect to the Bonds, the officers of the City are authorized to take all actions necessary to obtain such municipal bond insurance. The Mayor and City Clerk are authorized to agree to such additional provisions as the bond insurer may reasonably request and which are acceptable to the Mayor and City Clerk including provisions regarding restrictions on investment of Bond proceeds, the payment procedure under the municipal bond insurance policy, the rights of the bond insurer in the event of default and payment of the Bonds by the bond insurer and notices to be given to the bond insurer. In addition, any reference required by the bond insurer to the municipal bond insurance policy shall be made in the form of Bond provided herein.

Section 22. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the Common Council or any parts thereof in conflict with the provisions hereof shall be, and the same are, hereby rescinded insofar as the same may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.





## Notice of Sale





## **Bid Tabulation**





## Winning Bid





Said Bonds are redeemable as a whole or in part, and if in part, from maturities selected by the City, and within each maturity by lot (as selected by the Depository), at the principal amount thereof, plus accrued interest to the date of redemption.

[The Bonds maturing in the years \_\_\_\_\_ are subject to mandatory redemption by lot as provided in the resolutions referred to above, at the redemption price of par plus accrued interest to the date of redemption and without premium.]

In the event the Bonds are redeemed prior to maturity, as long as the Bonds are in book-entry-only form, official notice of the redemption will be given by mailing a notice by registered or certified mail, overnight express delivery, faesimile transmission, electronic transmission or in any other manner required by the Depository, to the Depository not less than thirty (30) days nor more than sixty (60) days prior to the redemption date. If less than all of the Bonds of a maturity are to be called for redemption, the Bonds of such maturity to be redeemed will be selected by lot. Such notice will include but not be limited to the following: the designation, date and maturities of the Bonds called for redemption, CUSIP numbers, and the date of redemption. Any notice provided as described herein shall be conclusively presumed to have been duly given, whether or not the registered owner receives the notice. The Bonds shall cease to bear interest on the specified redemption date provided that federal or other immediately available funds sufficient for such redemption are on deposit at the office of the Depository at that time. Upon such deposit of funds for redemption the Bonds shall no longer be deemed to be outstanding.

It is hereby certified and recited that all conditions, things and acts required by law to exist or to be done prior to and in connection with the issuance of this Bond have been done, have existed and have been performed in due form and time; that the aggregate indebtedness of the City, including this Bond and others issued simultaneously herewith, does not exceed any limitation imposed by law or the Constitution of the State of Wisconsin; and that a direct annual irrepealable tax has been levied sufficient to pay this Bond, together with the interest thereon, when and as payable.


This Bond has been designated by the Common Council as a "qualified tax-exempt obligation" pursuant to the provisions of Section 265(b)(3) of the Internal Revenue Code of 1986, as amended.

This Bond is transferable only upon the books of the City kept for that purpose at the office of the Fiscal Agent, only in the event that the Depository does not continue to act as depository for the Bonds, and the City appoints another depository, upon surrender of the Bond to the Fiscal Agent, by the registered owner in person or his duly authorized attorney, together with a written instrument of transfer (which may be endorsed hereon) satisfactory to the Fiscal Agent duly executed by the registered owner or his duly authorized attorney. Thereupon a new fully registered Bond in the same aggregate principal amount shall be issued to the new depository in exchange therefor and upon the payment of a charge sufficient to reimburse the City for any tax, fee or other governmental charge required to be paid with respect to such

registration. The Fiscal Agent shall not be obliged to make any transfer of the Bonds (i) after the Record Date, (ii) during the fifteen (15) calendar days preceding the date of any publication of notice of any proposed redemption of the Bonds, or (iii) with respect to any particular Bond, after such Bond has been called for redemption. The Fiscal Agent and City may treat and consider the Depository in whose name this Bond is registered as the absolute owner hereof for the purpose of receiving payment of, or on account of, the principal or redemption price hereof and interest due hereon and for all other purposes whatsoever. The Bonds are issuable solely as negotiable, fully-registered Bonds without coupons in the denomination of \$5,000 or any integral multiple thereof.

This Bond shall not be valid or obligatory for any purpose until the Certificate of Authentication hereon shall have been signed by the Fiscal Agent.

No delay or omission on the part of the owner hereof to exercise any right hereunder shall impair such right or be considered as a waiver thereof or as a waiver of or acquiescence in any default hereunder.


