MEETING MINUTES CHIPPEWA FALLS BUSINESS IMPROVEMENT DISTRICT BOARD OF DIRECTORS Thursday, August 31, 2023

The Business Improvement District (BID) Board of Directors met in the Chippewa Falls City Hall on Thursday, August 31, 2023 at 11:00 a.m. Present were: Nate Seckora Joel Jacobson, Greg Misfeldt and Garrett Bresina. Absent were Heidi Shervey, Paul Winger and Steve Harmon. Also present were: Council Member Paul Nadreau, City Clerk Bridget Givens, Teri Ouimette, Chippewa Falls Main Street Executive Director and Brad Hentschel, BID Secretary.

The meeting was called to order at 11:00 a.m.

1. Approve Minutes of the March 2, 2023 BID Board Meeting.

Motion by Seckora, seconded by Bresina to approve the minutes from the March 2, 2023 BID Board meeting. All present voting aye, motion carried.

2. Main Street request for second disbursement of 2023 BID funding. Possible recommendations to the Common Council

Motion by Misfeldt, seconded by Jacobson, to recommend to the City Council to authorize the second payment of the 2023 BID funding to Chippewa Falls Main Street, with the exception of \$500 to be retained in the account. All present voting aye, motion carried.

3. Main Street Report of current activities and update.

Teri Ouimette briefed the Board on 2023 activities thus far. Rotary Club is making great progress on remodel/redevelopment of Harmony Courtyard, including fencing replacement, concrete, pergola, painting, electrical and landscaping. Total investment from Rotary and City Grant (WEDC) will be \$60-70,000. Programming is beginning to be planned. Car shows have been well attended. Pure Water Days and Riverfest were excellent events, great collaboration with PD and security – no issues. Upcoming events include Paint the Town Pink, Small Business Saturday, Downtown Trick or Treating, Wagon Rides, Santa's House, Tree Lighting. Several new businesses relocating from neighboring communities filling vacant space. Two RLF loans have been provided to Farmer's Union and Collective Charm in addition to five signage/façade grants. Guided historic tours have been taking place of downtown historic points of interest.

No action taken.

4. Consideration of possible parking changes requested by Chippewa Falls Main Street. Possible recommendations to the Common Council.

Ouimette presented a request she will bring to Committee #3 to change Parking Lot #5 (near Falls Bowl) from a 4-hour limit to an 8-hour limit. A few businesses along Bridge Street between Grand Ave and Columbia St. have requested the change. Discussion occurred regarding the requested change including maintaining a transition of longer-term parking further from the downtown core which could also including modifying hours for Lot #4 (near Collective Charm), with the need to keep shorter-term parking along the streets and in lots

closer to the core of downtown. Also discussed merits of permit-based options for longer-term parking in time restricted lots.

Motion by Misfeldt, seconded by Seckora to support changing hours in Lot 4 and/or Lot 5 to maintain consistency with lot hour progression. Motion by Misfeldt, seconded by Seckora to amend the motion to recommend Committee 3 consider modifying time limits from 4 to 8-hours in Lots 4 and/or 5 and to discuss possibilities for permit parking. All present voting aye, motion carried. The BID Board then resumed to vote on the original motion as amended. All present voting aye, except Bresina who voted no. Motion carried 3-1.

5. Consideration of possible 2024 BID budget data and issues affecting the budget. Possible recommendations to the Council.

Council member Nadreau presented a request for BID Board participation on replacing Christmas decorations in and through downtown. This was on the list of considerations for ARPA dollars. BID Board and Main Street requested additional information from Nadreau.

Ouimette inquired about BID Board possibly considering funding a sign to be placed in the roundabout. BID Board requested Ouimette to establish a work group to present options to the BID Board for further consideration.

No action taken.

6. Adjournment.

Motion by Bresina, seconded by Seckora to adjourn. All present voting aye, motion carried. The meeting adjourned at 12:23 p.m.
