RE: Chippewa County Courts Continuity of Operation Plan

Ms. Givens:

Thank you for speaking with Judge Lane in his phone call with you on January 9, 2024. As discussed, the Chippewa County circuit court judges are preparing a continuity of operations plan (COOP) for continuing mandatory court functions in the event of an emergency. There are certain court functions that must continue, regardless of public health concerns, manmade disasters, or natural disasters. In the event that the Chippewa County Courthouse is unavailable for any emergency reason, mandatory court functions would need to continue at an alternate facility. After speaking with our Courthouse Security Committee, Emergency Management Director, and Information Technology Director, we believe the City of Chippewa Falls provides suitable alternative facilities necessary for mandatory court functions.

Specifically, we are aware that the County Information Technology Department provides support for the City of Chippewa Falls facilities, which would allow connectivity between the City of Chippewa Falls facility and the Chippewa County Jail, or other county facilities. There are certain court functions that cannot be supported with the City of Chippewa Falls facilities due to space and security needs, but many court hearings could be convened in the City Council chambers, or the Chippewa Falls Fire and Emergency Services Department Station 1 community/training room.

Therefore, we are requesting that this matter be forwarded to the appropriate City Council committee for further discussion. Please provide us with the meeting date for this respective committee, so that we may attend and provide additional information.

Any prospective agreement between the City and County would need to be addressed and approved by Randy Scholz, the Chippewa County Administrator. We look forward to your response.
