1. Discuss revisions to Wastewater Operator Job Description. Possible recommendation to the Council.

Director of Public Works/Utility Manager Cesafsky provided an updated Wastewater Operator Job Description. The recommendation was made to revise the requirement for a Commercial Driver's License (CDL) to include either possession of a valid CDL or the ability to obtain it within six months of employment. Cesafsky felt this would open the applicant pool.

Motion by Monarski/King to recommend Council approve the revised Wastewater Operator Job Description as presented. **All present voting aye, motion carried.**

2. Discuss Wellness Committee Proposal to hold a wellness event in conjunction with the safety picnic. Possible recommendation to the Council.

Parks, Recreation, and Forestry Director Jimenez appeared on behalf of the Wellness Committee and presented their proposal to hold a wellness event in conjunction with the annual safety picnic. The Wellness Committee is requesting the event be moved to Casper Park and to allow employees who are able to attend an extended lunch break from 11:30 am – 2:00 pm. They are also requesting that offices that have the ability to close be authorized to do so on the day of the event during the stated timeframe.

- Control rates of chlorination and de-chlorination and maintain gas chlorination and de-chlorination equipment.
- Schedule, clean, inspect, and maintain accurate records of collection system cleaning.
- Operate, regulate, and/or maintain the sanitary sewer collection system.
- Operate and maintain biosolids application equipment and accurate records of application.
- Perform routine cleaning duties, snow removal and grass cutting at treatment facilities.
- Perform Confined Space Entry work.
- Communicate with other operators and/or supervisors to coordinate materials handling and delivery.
- Perform necessary maintenance and preventative maintenance to assigned machinery and equipment.
- Respond to emergency situations including sewer back-ups, power outages, snow and ice events, high water, washouts, and others as directed.
