# MINUTES OF THE REGULAR MEETING OF THE COMMON COUNCIL

The regular meeting of the Common Council of the City of Chippewa Falls was held on Tuesday, March 5, 2013, in the City Hall Council Chambers. Mayor Greg Hoffman called the meeting to order at 6:30 pm. The Pledge of Allegiance was recited.

Mr. Dresel also expressed concern with Resolution 2013-08, specifically regarding street surfacing. Rubenzer advised that patching is a temporary fix, but that the City has an extensive chip sealing and crack sealing program.
