There was a motion by Flynn to approve the request of the Northern Wisconsin State Fair to use City equipment and/or personnel for fairground projects. Motion died for lack of a second. Motion by Hanke/Flynn to amend the motion to allow the Northern Wisconsin State Fair to use City equipment for fairground projects with the provision that the City has zero liability, zero City wages paid, and the work must be done off of City work time. Attorney Ferg was questioned about Workers' Compensation coverage and protection in the event of equipment failure/damage. He advised it is a gray area, but our insurance carrier agreed to defend with the understanding that the City be indemnified by the fair. Motion by Hanke/Flynn to amend the motion to allow the Northern Wisconsin State fair to use City equipment for fairground projects with the provision that there is zero cost to the City, zero liability on the part of the City, the City is indemnified in the case of equipment breakdown, and all operators of equipment are approved by the Street & Utility Maintenance Supervisor. Roll Call Vote: Aye Hanke, Flynn, Hull, Hicks; No Mason, Lardahl, Adrian. Motion carried.
- (b) Motion by Adrian/Hull to approve the proposal from Anderson-Moessner Appraisals, LLC to review and confirm the draw requests from SEH during the construction of the SEH office building.
