# OTHER NEW OR UNFINISHED BUSINESS AS AUTHORIZED BY LAW

- (a) Rubenzer informed Council that the Development Agreement is the standard agreement and has been approved by Attorney Ferg. Councilor Mason questioned if additional setback requirements would be necessary for safety concerns. Rubenzer advised that Wisconsin does not connect in to Chippewa Crossing Boulevard, so it is not necessary. Mason further questioned if a sound wall would need to be addressed to curb road noise from Business 29, and the Mayor stated that the noise is primarily from Highway 29, which we would have no control over. **Motion by Hicks/Adrian** to approve the Development Agreement relating to Marilyn Addition Plat by and between the City of Chippewa Falls and Frazer Construction. **Roll Call Vote: Aye Hicks, Adrian, Kiefer, Mason, Lardahl. Motion carried.**
- (b) Rubenzer met with Ken Custer of Chippewa Valley Grain and Processing who is requesting a permit for overweight sealed transport within the City limits. The loaded container weight requested would be consistent with what is allowed by state law. **Motion by Hicks/Kiefer** to approve the Request of Overweight Sealed Container Transport Permit from Chippewa Valley Grain and Processing Inc. **Roll Call Vote: Aye Hicks, Kiefer, Lardahl, Adrian, Mason. Motion carried.**
- (c) Attorney Ferg shared that SEH wanted to change how funds are being held by Chippewa Valley Title & Abstract to allow a more workable system for the subcontractors. The protections in place would require a lien waiver to be signed and returned before any further draws are made. Chippewa Valley Title & Abstract would insure the City and Redevelopment Authority against any mechanics liens. Motion by Mason/Hicks to approve Amendment No. 1 to Disbursing Agreement between the City of Chippewa Falls and Short Elliott Hendrickson, Incorporated. Roll Call Vote: Aye Mason, Hicks, Adrian, Kiefer, Lardahl. Motion carried.
- (d) Attorney Ferg advised this agreement was developed to provide more definition and structure to what has already been agreed upon. Councilor Mason wanted to ensure it was noted that the monies being used for this purchase were bond monies being funded by donor TIF #11, not being assessed to the taxpayer.

  Motion by Hicks/Adrian to approve the Purchase, Sale, and Development Agreement between the Chippewa Falls Area Chamber of Commerce and the City of Chippewa Falls. Roll Call Vote: Aye Hicks, Adrian, Kiefer, Mason, Lardahl. Motion carried.
