Transportation, Construction, Public Safety and Traffic

Committee #3 met Tuesday, February 21, 2012 at 3:00 p.m. in the City Hall Council Chambers, 30 West Central Street, Chippewa Falls, WI.

Attendees: Bill Hicks, Mike Hanke, CW King, Mayor Hoffman, and Director of Public Works Rick Rubenzer.

The meeting was called to order at 3:00 PM.

Item 1. Discuss and consider amending the Smoking Prohibition Ordinance, § 10.05 of the City Code, to include a provision which would prohibit smoking in the vicinity of the entrance to the Chippewa Falls Public Library with possible recommendations to Common Council.

Motion by Hicks/Hanke, with Hicks and Hanke voting aye, and King voting no to recommend the City Council Amend Smoking Prohibition Ordinance 10.05 to prohibit smoking on Public Library property. **Motion carried.**

Item 2. Discuss and consider amending Chapter 7- Traffic Code, §7.09 - Parking Restrictions, of the City of Chippewa Falls Municipal Code and make recommendation to the Common Council.

Motion by Hicks/Hanke, all present voting aye, to recommend the City Council amend Chapter 7 – Traffic Code, 7.09 by deleting the following from 7.09(1)(c) “50 feet east of the painted and designated crosswalk located in front of 1201 Miles St. to a point 50 feet west of said crosswalk and from a point”. **Motion carried.**

A copy of the proposed change is attached.

Item 3. Discuss and consider approving a Sidewalk Use Permit Application for the Salvation Army Thrift Store for a sandwich board sign to advertise sales one to two times per week for the remainder of 2012 and make recommendation to Common Council.

Motion by Hanke/Hicks, all present voting aye to table item 3. **Motion carried.**

Item 4. Discuss and consider changing the 15 minute parking limit on Grand Avenue in front of the Chippewa Falls Museum of Industry and Technology and make recommendation to Common Council.

Motion by Hanke/Hicks, all present voting aye, to recommend the City Council approve changing the 15 minute parking on Grand Street in front of the Museum of Industry and Technology to 2 hour parking. **Motion carried.**

Item 5. Discuss and consider removing the reserved designation from the nine parking stalls next to the Chippewa Falls Museum of Industry and Technology building and make recommendation to Common Council.

Motion by King/Hicks, all present voting aye, to table Item 5. **Motion carried.**

Item 6. Adjournment. Motion by Hanke/King, all present voting aye, to adjourn at 3:45 PM. **Motion carried.**
